INTERNATIONAL CONFERENCE "STATELESSNESS: AD LIMEN CIVITATIS"

Last December was the sixtieth anniversary of the ratification by Italy of the 1954 Convention relating to the status of stateless persons. On the occasion of this anniversary, the idea of this conference was developed to examine and reflect on the issue of statelessness. Statelessness is a human rights violation affecting millions of people around the world. Stateless persons without recognition have no citizenship and do not enjoy basic human rights. Indeed, the recognition of statelessness plays an important role in strengthening respect for the human rights of stateless persons, in particular through access to a secure legal status and the enjoyment of rights granted under the 1954 Convention.

This conference aims to highlight not only the condition of those individuals that no State considers as its own citizens and to whom the fundamental right to citizenship is not recognized, but also wants to highlight how being recognized as stateless finally kindles hope, in the person who until then had lived as a shadow, to put an end to the problems through the acquisition of citizenship, constituting a first step towards acceptance into society. The hope that an improvement in his life is imminent, encouraging him to remain confident about his future and his existence.
